  - Members of the interest network continued to provide representation as reviewers on 2025 Conference Proposal Review Panels, Fellowship and Awards Committees.
  - Members moderated sessions relevant to legal process & public policy topics during 2025
     AAIDD Annual Conference including concurrent session on recent supreme court decisions and implications for AAIDD led by Ann Delphi of University of New Mexico.
  - Members contributed articles on research and policy to AAIDD journals.
  - Continued collaboration with DSP Interest Network to identify and discuss topics of intersection between public policy implications and current direct support workforce challenges.
- 3. Improve communication and engagement among LP&PP members in network activities. Communication with LP&PP members continued to be informal during 2025 with plans to formalize and engage interest network members in the year ahead. Due to scheduling issues, competition with other interest networks, and time constraints, the LP&PP does not hold its annual meeting at the AAIDD conference.

  - In 2025, the LP&P awarded one \$600 scholarship for SECP member to attend the 2025 AAIDD conference in Arlington, VA this past year. During 2025, the LP&PP co-chairs continued to explore & respond to opportunities to engage with the SECP Interest Network members.

Explore providing up to 10 AAIDD memberships to the Legal Process and Public Policy Interest Network for students/early career professionals who are transitioning out of SECP whose area of study or practice focuses on disability law, policy and systems change at the state and or federal levels.
