

The Environmental Health Initiative (EHI) of the American Association on Intellectual and Developmental Disabilities spear-headed and participated in a Biomonitoring Project this past year called Mind Disrupted (www.minddisrupted.org). The project, initiated by the Learning and Developmental Disability Initiative (LDDI) and Commonweal, with support from Safer Chemicals Healthy Families, raised awareness among participants (those whose body fluids were tested for chemicals) and the public of the burden of toxic chemicals all of us carry in our bodies, including people with disabilities. At the AAIDD annual meeting, the EHI will share the results of this project with our members, and talk about what we can do as individuals and as a community about the chemicals that exist in our bodies. Speakers will include Laura Abulafia. Director of Education and Outreach for the EHI, as well as Rob Fletcher. Executive Director of the NADD.

The Rational Use of Psychotropic Medication for Individuals with Intellectual Disabilities: Pathways to and from Polypharmacy

Presenter: Edwin J. Mikkelsen, MD, Associate Professor of Psychiatry, Harvard Medical School; and Medical Director, The MENTOR Network, Boston, MA

This presentation will focus on methods to reduce the unnecessary use of psychotropic medication for individuals with intellectual disabilities who are also diagnosed with psychiatric disorders.
