## **2013 Henri J.M. Nouwen Leadership Award**

to Sister Gabrielle Kowalski, OSF, PhD



For over 40 years, Sr. Gabrielle Kowalski has been a powerful and effective advocate for people with intellectual and developmental disabilities, particularly with regard to understanding, respecting, and supporting their spiritual lives.

She began her career as a special education teacher in 1963 and went on to become

Professor of Special Education and Associate Dean for Teacher Education at Cardinal Stritch University.

Sister Gabrielle has had a direct impact on students with disabilities, and has helped shape the careers of other professionals and the perspectives of professional organizations. She served as editor of the newsletter of the National Apostolate for Inclusion Ministry (NAfIM); president and past president of the AAIDD Religion and Spirituality Division; and member of the Division's Work Group on Certification for Spiritual Support Professionals.

Her work has been published in numerous journals, including those of AAIDD. In addition, she is a sought-after presenter at state and national conferences and has used those opportunities to raise the level of thinking among religious professionals.

Highly regarded among her professional and academic colleagues, Sister Gabrielle was named Professor Emeritus by Cardinal Stritch University in 2012. The Religion and Spirituality Division is pleased to recognize Sister Gabrielle's good work.
